### RISK RATINGS

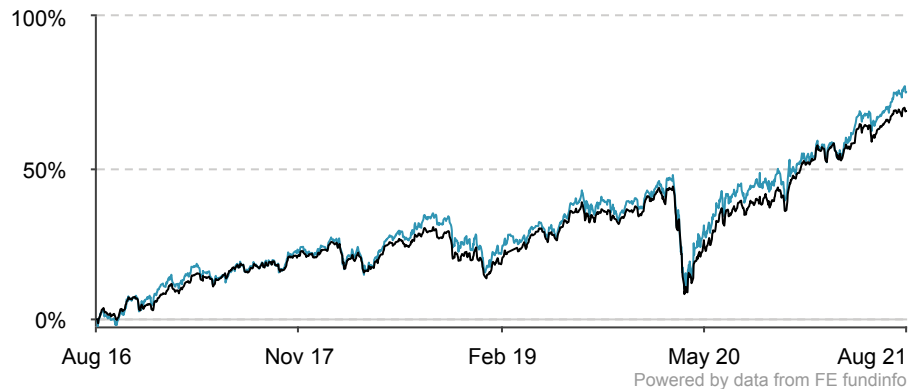
### FUND OBJECTIVE
