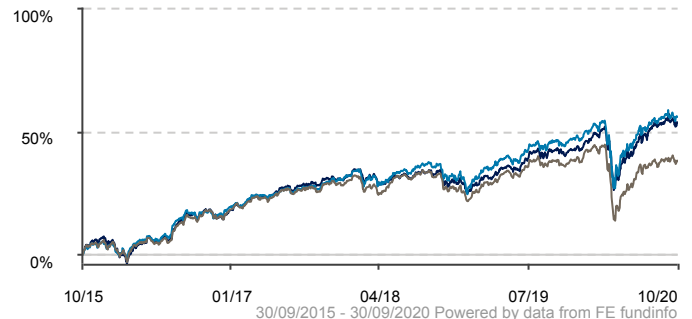

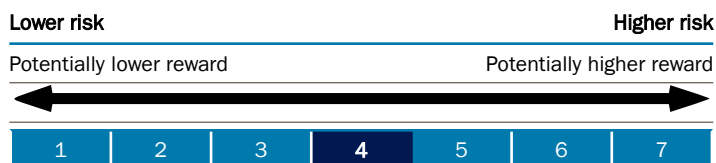

## Risk Profile
