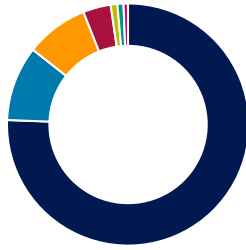

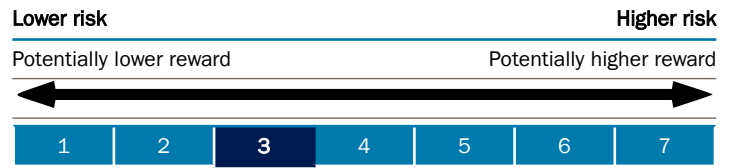

Risk Profile
