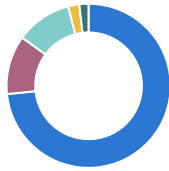

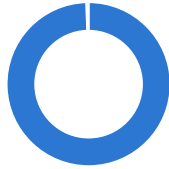
## GEOGRAPHIC ALLOCATION (%)

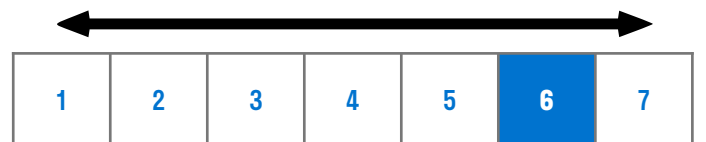
