<p>This fund is also referred to as SL Managed Cash CP Pension Fund.</p> <p>The Fund aims to provide a return that is in line with money market rates by investing in one or more money market funds.</p> <p>The Fund's holdings will typically invest in a portfolio of money market instruments, including Certificates of Deposits (CD's) and Floating Rate Notes (FRN's). They may also invest a proportion of assets in investment grade bonds issued by sovereign governments, such as the United Kingdom.</p> <p>The Fund price is not guaranteed by Standard Life and there could be circumstances where the Fund price may fall. A fall might happen if, for example, there is a default by one of the banks where some of the money is held or where there is an adverse market movement in the value of some of the money market instruments held. A fall may also happen if interest income falls so low as to be less than the charges applied to the fund.</p> <p>The Fund may invest in Standard Life Funds managed by either Standard Life Investments or by 3rd party fund managers. Where the Fund invests in more than one fund, the allocation between these funds will be re-balanced periodically.</p> <p>The Sterling value of overseas assets held in the Fund may rise and fall as a result of exchange rate fluctuations.</p> <p>The Fund has been designed by the Trustee Directors who comprise the Defined Contribution Sub-committee (that represents the Centrica Pension Scheme, Centrica Pension Plan and Centrica Engineers Pension Schemes) in conjunction with their advisers specifically for the following scheme sections: Centrica Savings Plan, Centrica Savings Plan ( 2011 Section) and Centrica Engineers Savings Plan. 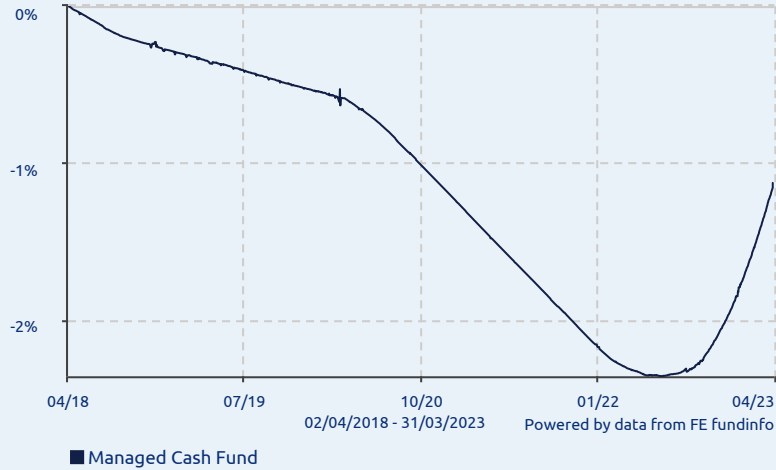
