Where the Fund invests in more than one fund, the allocation between these funds will be re-balanced periodically.</p> <p>The value of investments within the Fund can fall as well as rise and is not guaranteed – you may get back less than you put in. 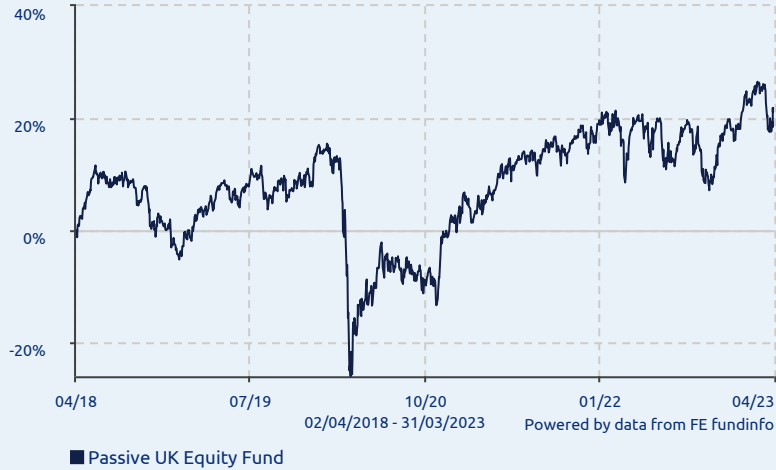
