The goal of this Fund is to achieve long-term growth by primarily investing 50% in the shares of companies listed on the UK stock market and 50% in shares listed on overseas stock markets. It does this by investing directly in shares or indirectly through other funds. The proportions held in each component will vary from time to time around the long-term strategic asset allocation of 50% in UK equities and 50% in overseas equities.

These funds are not restricted to a particular fund manager or investment strategy and can be passively and/or actively managed. These funds can change from time to time without notice, to ensure the Fund continues to meet its goal.

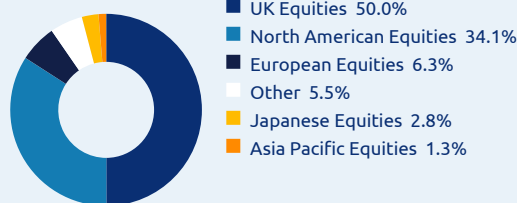

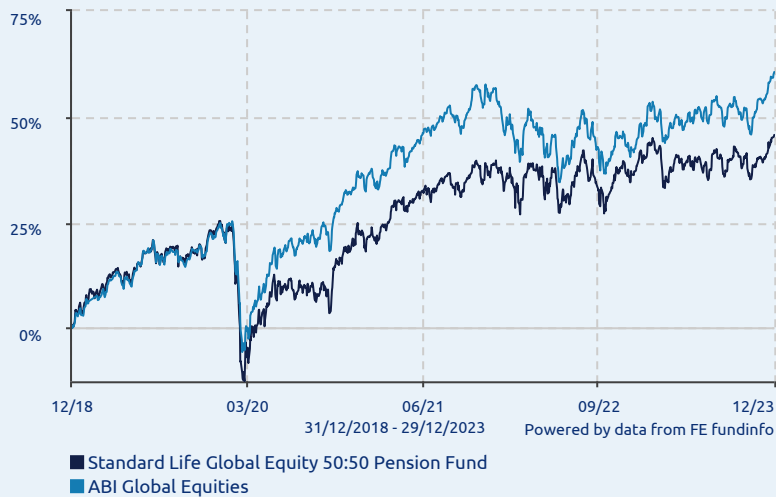
