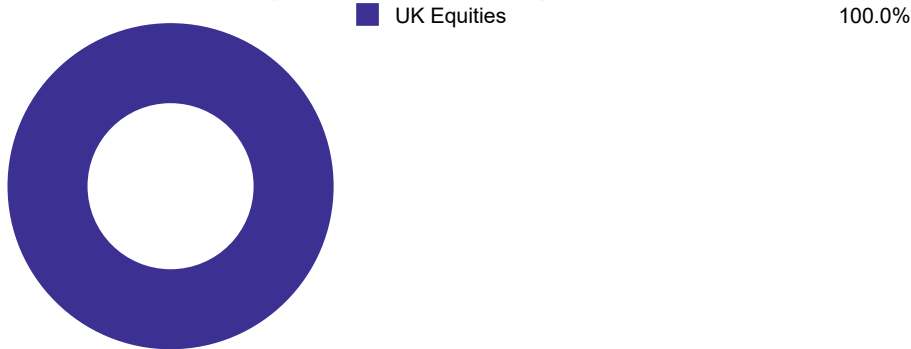

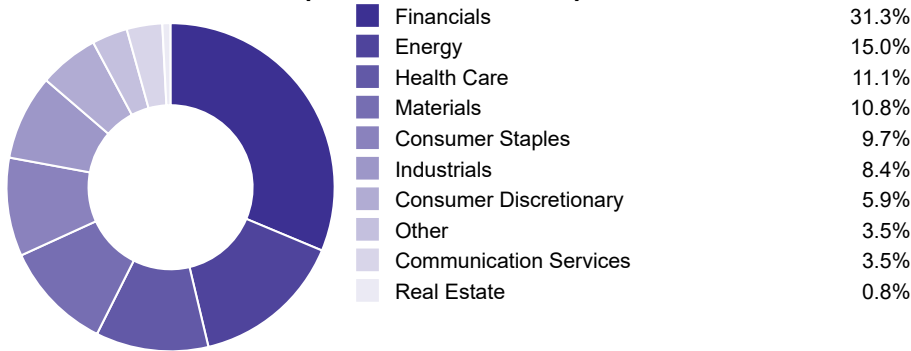

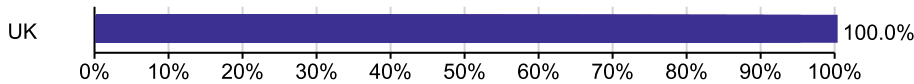
Asset Allocation (as at 31/10/2021)
