## SWIS UK Equity Tracker B Life

### Fund Aim

The fund invests via the HBOS Investment Fund Managers Limited (HIFML) UK Equity Tracker OEIC Fund. The OEIC Fund aim is to match as closely as possible the performance of the FTSE All-Share Custom Screened Index (the "Benchmark Index"), before deduction of fees, by investing in UK shares. The Fund aims to invest in shares of all of the companies within the Benchmark Index. This is often referred to as a 'full replication' approach. Where HIFML believes it can provide an advantage to the Fund in managing costs, to achieve a more efficient way of tracking the Benchmark Index, or where there are exceptional market circumstances, the Fund may include or exclude specific shares and/or other security types which are representative of a share in the Benchmark Index (such as depositary receipts). The Fund may also invest, up to 10%, in other funds to gain exposure to the Benchmark Index. Derivatives and stock lending may only be used for efficient portfolio management purposes. The Benchmark Index measures the performance of a sub-set of equity securities within the FTSE All-Share Index (the "Parent Index"). The Parent Index provides a representation of the returns of securities in the UK equity market by measuring the performance of shares of small, medium and large companies listed in the UK. The Benchmark Index excludes companies from the Parent Index based on the HIFML exclusions screening criteria in relation to controversial weapons, violations of United Nations Global Compact principles, Thermal Coal and Tar Sands as well as Tobacco.

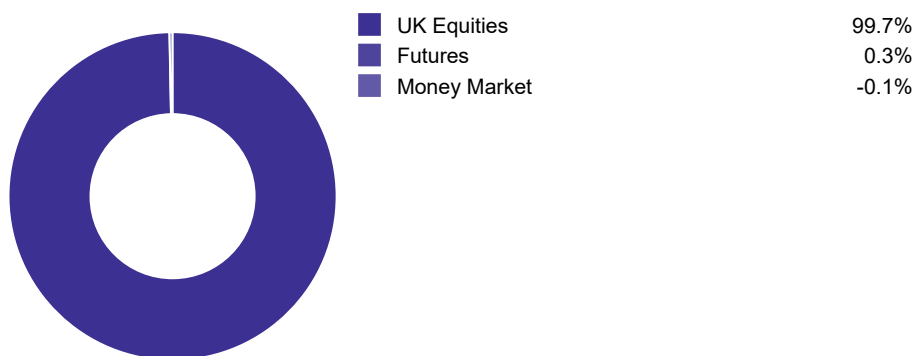
### Information Statement

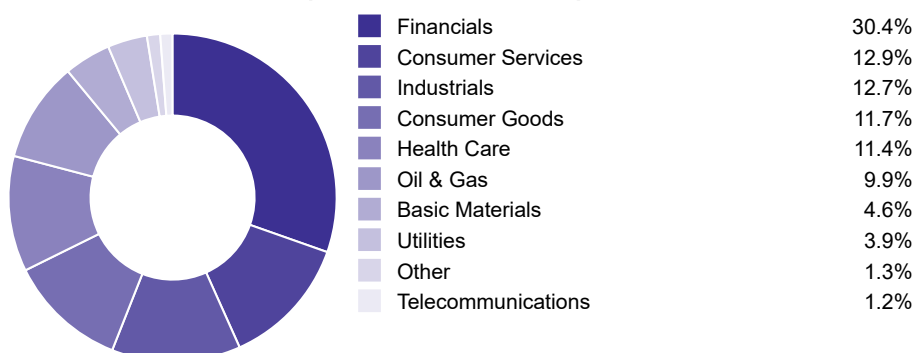

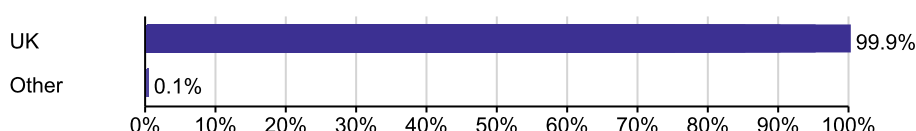
### Asset Allocation (as at 31/12/2024)

### Regional Breakdown (as at 31/12/2024)



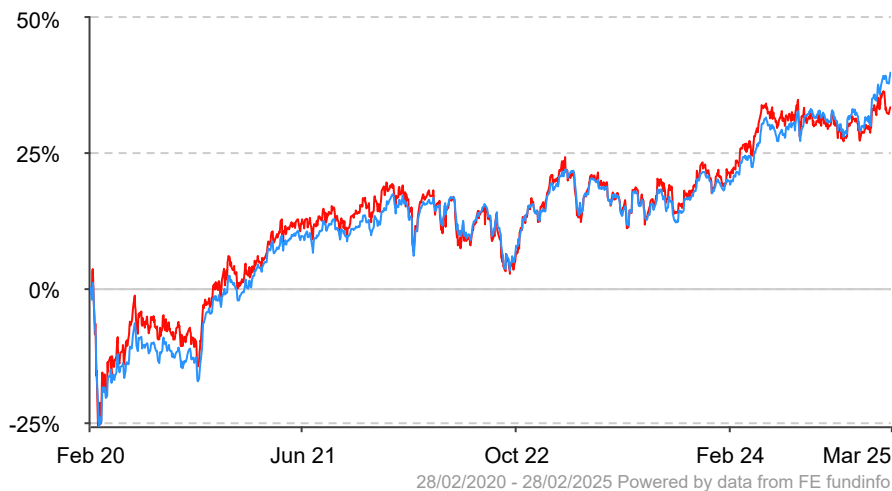

## Quarterly Fund Manager Review

UK equities were lower over the quarter. Following the tax rises in the Autumn Budget, there was an atmosphere of austerity and the economy stagnated. In November, the election of Donald Trump in the US prompted fears over potential tariffs and how they would hit the UK export market. To add to the economic woes, December then saw a rise in inflation, and the Bank of England (BoE) decided not to cut interest rates at its final policy meeting of the year. The quarter saw increasing concern over the outlook for the UK's economy. Long-term bond yields soared as concerns grew over the UK government's fiscal policies and budget deficit, and inflation expectations rose. Economic growth flatlined since the Labour government came to power in July, in part due to depressed consumer and business confidence as Chancellor Reeves warned of tax rises and pain to fix the inheritance left by the former government. GDP for October fell by 0.1% month on month, following a fall of 0.1% in September, and third-quarter growth data was revised down to 0%, which renewed concerns over a recession. The UK composite purchasing managers' index (PMI) dropped to 50.4 in December, which marked the fourth consecutive month of slowing growth and was the lowest level since October 2023 (below 50 indicating economic contraction). Cost pressures for companies increased due to the policies set out in the Autumn Budget on 30 October, including rises in employers' National Insurance contributions and the National Living Wage, encouraging companies to raise prices to soak up the costs. There were signs these policies could already be weighing on the jobs market and inflation. Hiring data was weak in the run-up to Christmas and private sector employment saw its steepest decline since January 2021. Meanwhile, UK inflation rose to 2.6% in November, up from 1.7% in September. The BoE cut interest rates in November by 25 basis points (bps) but made no change at the December meeting. Markets then forecast fewer rate cuts in 2025 than previously expected, with just two 25bps reductions expected this year.
