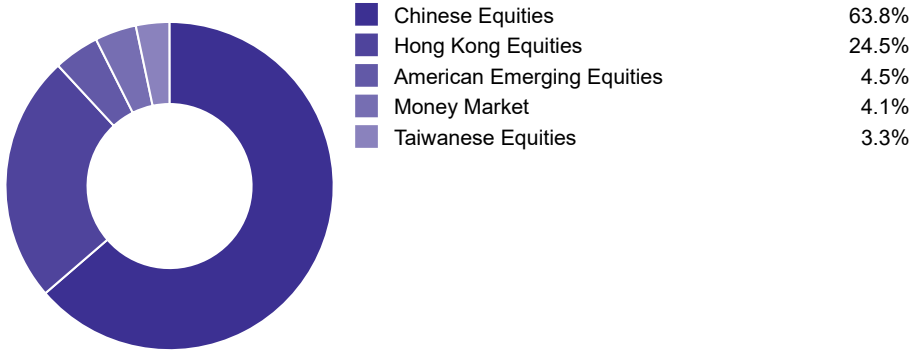
### Fund Aim

### Asset Allocation (as at 31/01/2025)



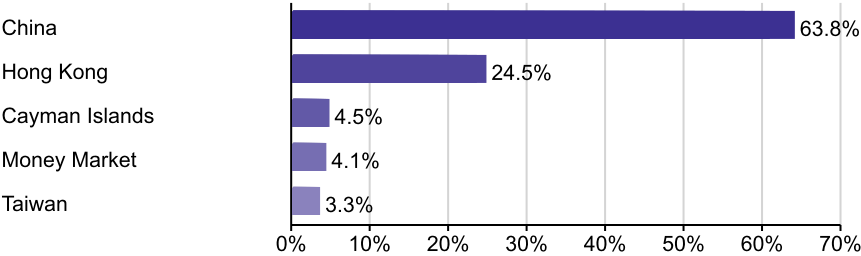

### Regional Breakdown (as at 31/01/2025)



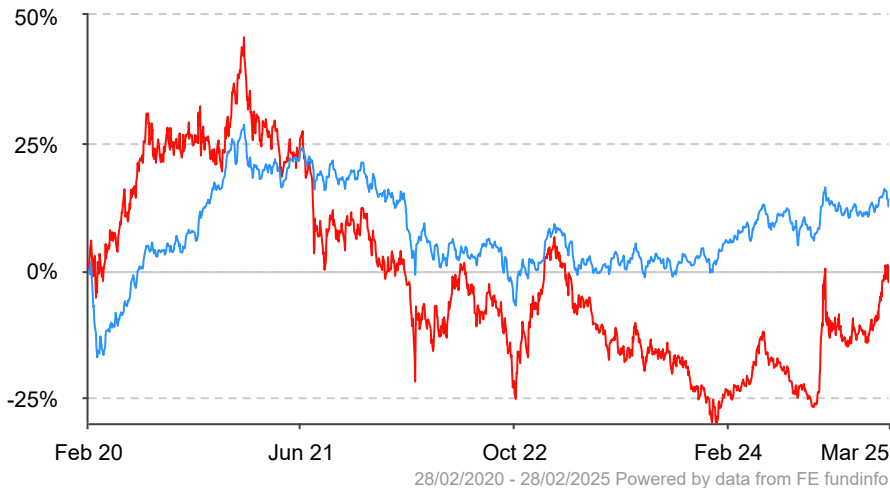

## Quarterly Fund Manager Review

China stimulus hopes buoyed Asian markets in Q3, but a lack of detail on measures to improve domestic demand disappointed in Q4. Meanwhile Asian equity markets and currencies responded negatively to the US presidential election result given concerns over Trump's protectionist policies and lowered expectations over the scope for further US rate cuts in 2025.
