What is this Product?

On the 21 June 2018 the Company announced proposals to merge with Standard Life UK Smaller Companies Trust plc. A copy of the announcement can be found on the Company's website and a circular containing further details was published on 4 September 2018. Ordinary Shares in Dunedin Smaller Companies Investment Trust PLC, an actively managed investment company registered in Scotland and listed on the London Stock Exchange. Its investment objective is to achieve long-term growth from a portfolio of smaller companies in the United Kingdom. The Company invests primarily in equity securities and typically does not acquire securities that are unquoted or unlisted at the time of investment. The Company has borrowed to purchase assets. The Company does not have a fixed life. Aberdeen Standard Fund Managers Limited may not unilaterally terminate the Ordinary Shares however the Company may be wound up with shareholder approval. Shares in the Company are bought and sold on a stock market. Investment in the Company is only suitable for investors who are comfortable with the risks and investment time horizon set out in this document and may not be appropriate if you plan to sell some or all of your shares within 5 years. In assessing its performance, the Company compares its investment return with that of the FTSE SmallCap (ex Investment Companies) Index. What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Company is not able to pay you.

What happens if the Company is unable to pay out?

What are the costs?

How long should I hold it and can I take money out early?

This product has no required minimum holding period but is designed for medium to long-term investment. Since the value of investments and the income from them can rise and fall over differing time periods, you should have an investment horizon of at least 5 years when buying an investment of this type.

The minimum recommended holding period is therefore 5 years.

As the shares are listed on the London Stock Exchange, you may buy or sell shares on any normal business day that the London Stock Exchange is open for business.
