### What is this Product?

The Fund is a sub fund of a non UCITS open ended investment company and there is no fixed term or maturity date. It is classified as a fund of funds which is a fund that invests in a number of other funds. Fund launch date: 14/09/2004.

#### Objective and Policy

The objective is to seek to provide a modest return achieved through investment in a range of funds which invest in various lower-risk asset classes.

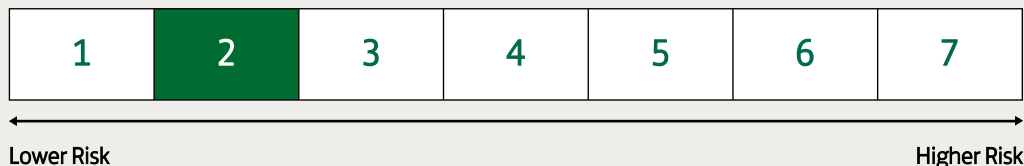
The policy is to invest in collective investment funds and multimanager funds managed by a range of fund managers including, but not limited to, Lloyds Investment Fund Managers Limited and other subsidiaries of Lloyds Banking Group plc. These funds, in turn, invest in a number of asset classes. These could include, but are not limited to bonds, equities, properties and cash.

This Fund may be suitable for you if you are willing to risk a loss to your capital and are looking for a medium to long term investment.

The Fund can be terminated without the agreement of shareholders, if the value of the Fund is less than £5,000,000 or currency equivalent for a period of four consecutive weeks. Shareholders will be given at least three weeks' written notice of any such action.

### What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk and volatility of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or the type of underlying assets in which the Fund invests.



The risk indicator assumes you keep the product for a minimum of five years.

The actual risk can vary significantly if you sell your shares at an early stage and you may get back less.

We have classified this product as 2, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the amount you could get back.

The base currency of the Fund is sterling. It can invest in securities denominated in currencies other than sterling so can be affected by currency fluctuations which may affect the return. The return from investing in a fund denominated in a currency other than the currency of your residence or domicile may be affected by currency fluctuations. Dividends, which will be automatically reinvested in shares of the Fund, are not guaranteed and the amount you receive may fluctuate.

## What happens if Lloyds Investment Fund Managers Limited is unable to pay out?

In the event of the default of the manager or custodian of the Fund, limited protection is provided under the Collective Investment Funds (Recognized Funds) (Compensation for Investors) (Jersey) Regulations, 1988. The maximum amount of compensation payable to any one investor is £48,000, but is subject to the total amount of compensation in any one year being limited to £5,000,000.

## What are the costs?
