### What is this Product?

The Fund is a sub fund of a non UCITS open ended investment company and there is no fixed term or maturity date. Fund launch date: 02/10/2006.

#### Objective and Policy

The objective is to seek a high income from a spread of fixed interest securities denominated predominantly in euro.

The policy aims to support the payment of dividends above the level of short term euro interest rates. This policy may result in a gradual reduction in the capital value of your shares.

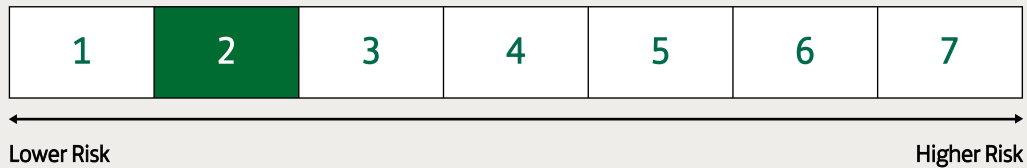
If interest rates rise, the fixed income earned from bonds (fixed interest securities) becomes less attractive to investors, so the demand for bonds may fall and their capital value may decrease. Bonds may be affected by changes in interest rates, inflation and any decline in the creditworthiness of the issuer.

This Fund may be suitable for you if you are willing to risk a loss to your capital and are looking for a medium to long term investment.

The Fund can be terminated without the agreement of shareholders, if the value of the Fund is less than £5,000,000 or currency equivalent for a period of four consecutive weeks. Shareholders will be given at least three weeks' written notice of any such action.

### What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk and volatility of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or the type of underlying assets in which the Fund invests.



The risk indicator assumes you keep the product for a minimum of five years.

The actual risk can vary significantly if you sell your shares at an early stage and you may get back less.

We have classified this product as 2, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the amount you could get back.

The base currency of the Fund is euro. It can invest in securities denominated in currencies other than euro so can be affected by currency fluctuations which may affect the return. The return from investing in a fund denominated in a currency other than the currency of your residence or domicile may be affected by currency fluctuations. Dividends are not guaranteed and the amount you receive may fluctuate.

## What are the risks and what could I get in return? (continued)

This table shows the money you could get back over the next 5 years, under different scenarios, assuming that you invest €10,000. The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products.

## What happens if Lloyds Investment Fund Managers Limited is unable to pay out?

In the event of the default of the manager or custodian of the Fund, limited protection is provided under the Collective Investment Funds (Recognized Funds) (Compensation for Investors) (Jersey) Regulations, 1988. The maximum amount of compensation payable to any one investor is £48,000, but is subject to the total amount of compensation in any one year being limited to £5,000,000.

## What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. The figures assume you invest €10,000. The figures are estimates and may change in the future.
