About fund performance

Our risk rating



Low risk

Low risk funds will typically have underlying investments that we'd expect to experience small changes in value from day-to-day. The fund price movements will generally be positive but could be negative, particularly in a low interest rate or inflationary environment. Funds with a low risk rating may keep risk down in a variety of ways, for example by holding a very broad range of investments, or they may contain a narrower range of fixed interest or cash investments with a short term to maturity. Over the longer term, they're unlikely to deliver high levels of return and may not keep pace with inflation.

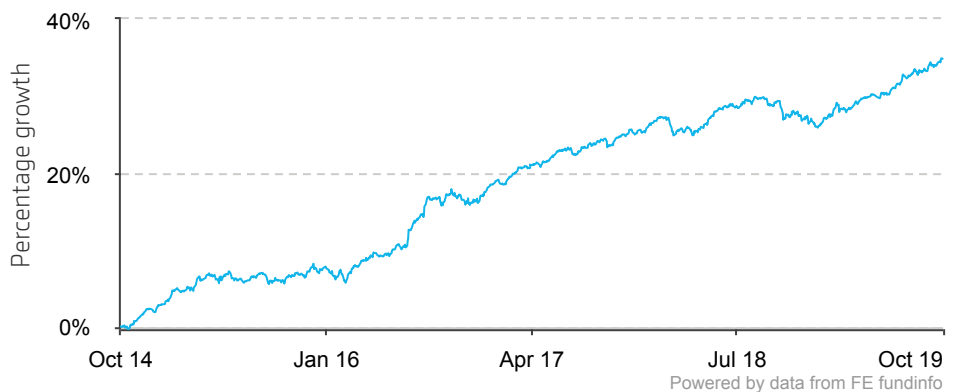
Fund objective

This fund aims to achieve long-term capital growth by investing mainly in a wide range of UK and overseas fixed interest securities but can also invest up to 50% in equities. The fund's returns are smoothed daily, generally by taking the fund performance to be halfway between the actual returns on the investments and the disclosed expected growth rate (EGR) (this is the rate at which we expect the underlying investments to grow). This helps to reduce the effects of stockmarket fluctuations. We may change the EGR in the future but won't change it retrospectively unless the smoothed fund value and the actual market value of the investments differ by more than 5%. In this case, we'll modify the calculation of the daily smoothed return to gradually bring the difference back within 5%.

Fund performance

Risks specific to this fund

There is no guarantee the fund will meet its objective. The value of an investment can fall as well as rise and investors could get back less than they originally invested. All funds carry a level of risk and the information below outlines the key risks for this fund.

Currency risk - this fund invests overseas so its value will go up and down in line with changes in currency exchange rates. This could be good for the fund or bad, particularly if exchange rates are volatile.

Third party risk - in the event that the underlying investments which the fund invests in suspend trading, Aegon may defer trading and/or payment to investors. The value ultimately payable will depend on the amount Aegon receives or expects to receive from the underlying investments.

Credit risk - this fund invests in bonds or other types of debt. Bonds are essentially loans to companies, governments or local authorities so there's a risk that these companies or government bodies may default on the loan. Bonds are rated in terms of quality, usually from AAA down to B and below. AAA is the highest quality and therefore the least likely to default and B or lower the most likely to default. Where we have it we show the credit quality of the loans held by this fund.

Inflation risk - this fund invests in lower risk investments, which means it shouldn't fluctuate in value greatly and is less likely to fall in value significantly. The downside to this is that returns are likely to be lower and there's a greater risk that they may not keep pace with inflation. It's therefore more suitable for short-term investment where you may need your money quickly.

Interest rate risk - interest rate changes could affect the value of bond investments. Where long term interest rates rise, the value of bonds is likely to fall, and vice versa.

Smoothing risk - when investors take money out of the fund this can result in smoothing profits or losses for the fund, typically half of which are immediately reflected in the daily unit price. To make sure all investors receive their fair share we may, under certain conditions, apply additional smoothing adjustments either up or down when investors take their money out of the fund. Smoothing will not be able to counteract the impact of a sustained decline in investment returns.
