### **Fund Profile**

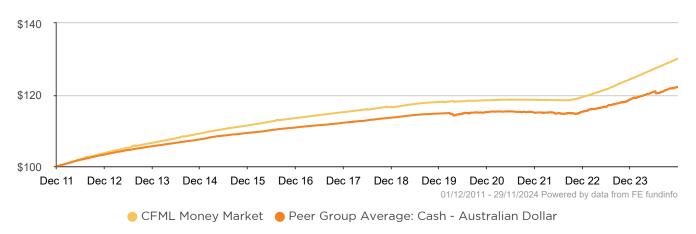
The Fund's objective is to provide a total return (before fees, costs and taxes) that exceeds the Bloomberg AusBond Bank Bill Index over a 1 year period.

ClearView Financial Management Limited (CFML) retains day-to-day control over the operation of the fund.

ClearView outsources the management of the CFML Money Market Fund to First Sentier Investors. First Sentier Investors is one of the largest managers of cash funds in Australia. The CFML Money Market Fund invests in a range of money market securities, including negotiable certificates of deposit, convertible term deposits, residential mortgage-backed securities and asset-backed floating rate notes, deposit accounts and overnight cash deposits.
