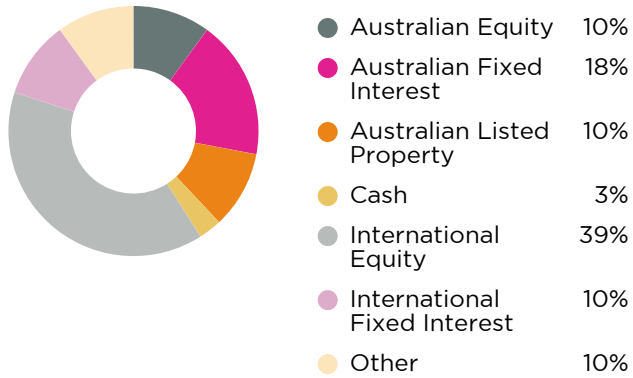

### Growth of \$100 since inception<sup>^\*</sup>

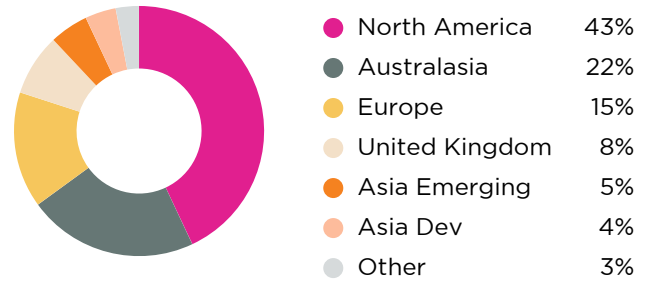
