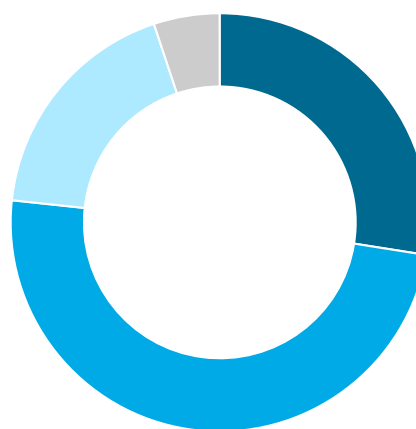

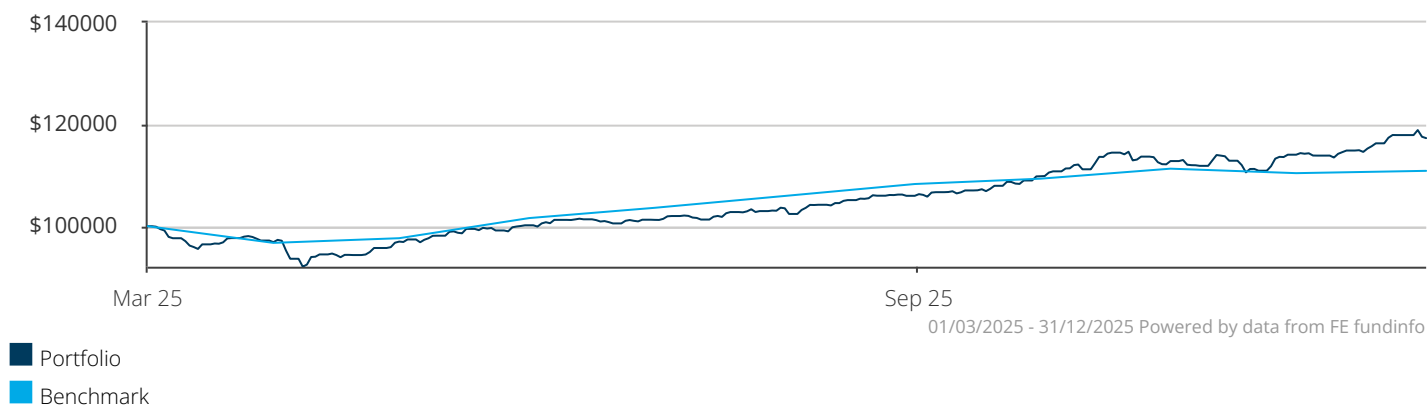

Quarterly manager commentary

Market Update

The December quarter saw dispersion in equity markets, with S&P500 Total Return index rising 2.65%, versus the ASX S&P200 Total Return Index falling 1.01%. Further, Small Cap equities significantly out performed Large cap in Australia, with the ASX Small Ordinaries Total Return Index returning 1.80% for the Quarter. Duration struggled, the Bloomberg Aus bond Composite Bond Index returning -0.15% for the quarter, as persistent inflation concerns and RBA commentary saw any hopes for rate cuts well and truly disappear. In fact, the market is now pricing in rate rises during 2026.

In other major asset classes, once again, it was all about Gold and Silver during the December quarter. Gold surged 10.70% in AUD terms, whilst Silver ran even harder, rallying more than 50% for the quarter (in AUD terms).

Portfolio Update

The Executive Series significantly outperformed its benchmarks across all portfolios during September. This large outperformance was reflected in the quarterly numbers also. Our large overweight holdings in Gold and Silver were significant contributors. Pleasingly, our manager selection also led to outperformance of relative benchmarks for all asset classes except listed property. We remain significantly overweight Gold and Silver across all portfolio, and invested in Floating Rate funds in the fixed income sleeve.

Portfolio changes during the quarter:

In the Global Equity Sleeve, we removed Aoris International Fund (PIM0058AU), and Ausbil Australian Active Equity Fund from the Australian Equity Sleeve. Inclusions for the quarter were L1 Capital Long Short Fund (ETL0490AU) and in the Global Equity Sleeve, Ophir Global Opportunities Fund (PIM7560AU).
