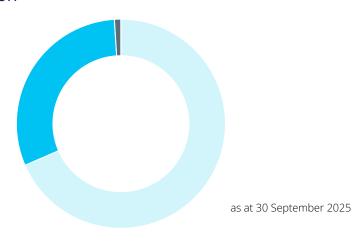

Asset allocation



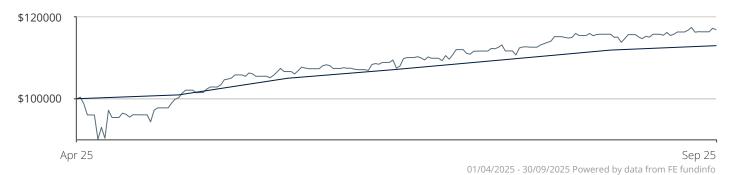
