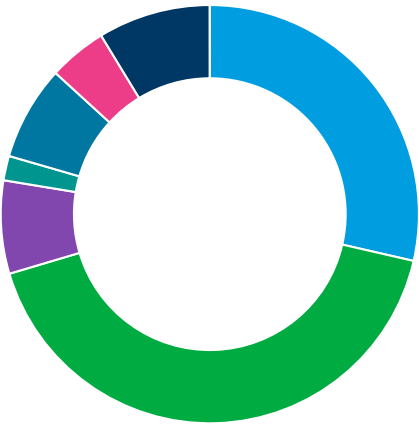
Mercer

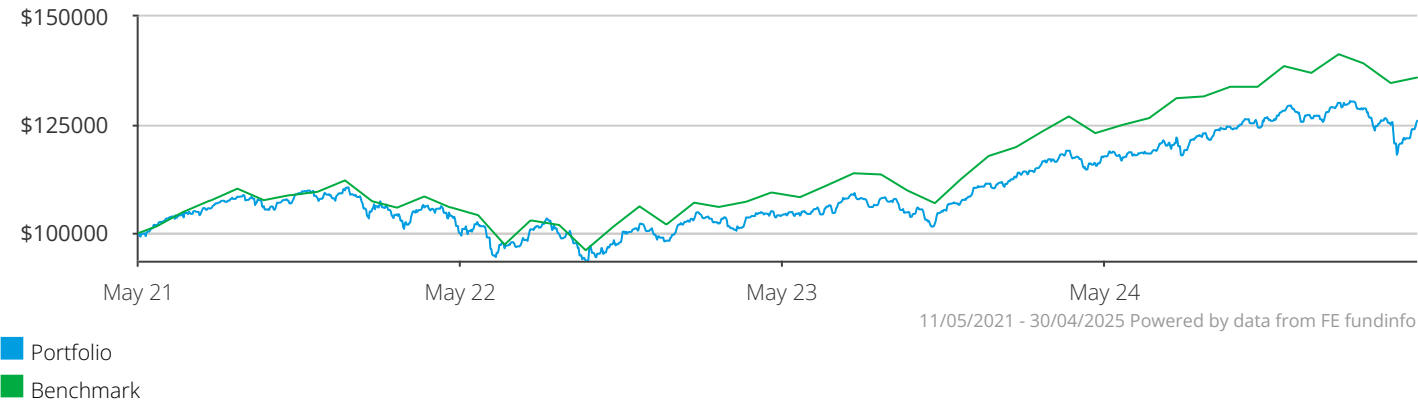
