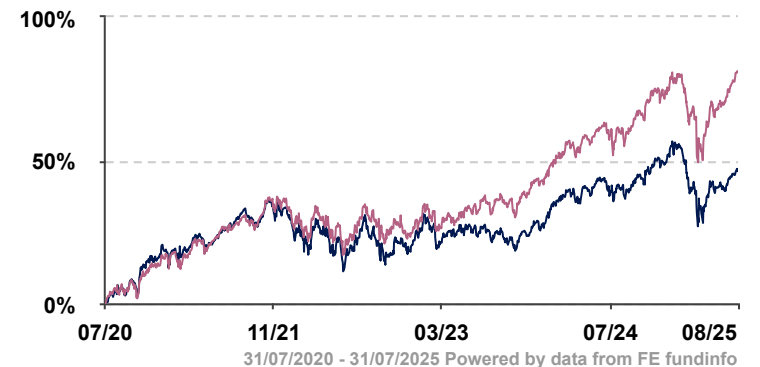

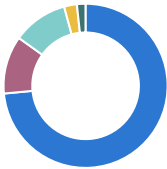

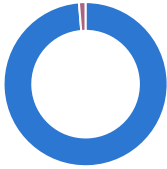
GEOGRAPHIC ALLOCATION (%)

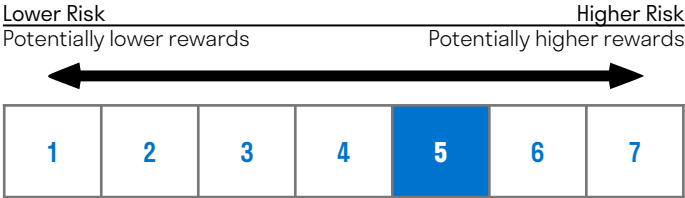
