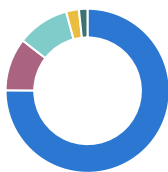

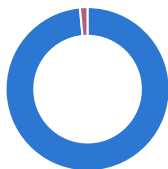
GEOGRAPHIC ALLOCATION (%)
