

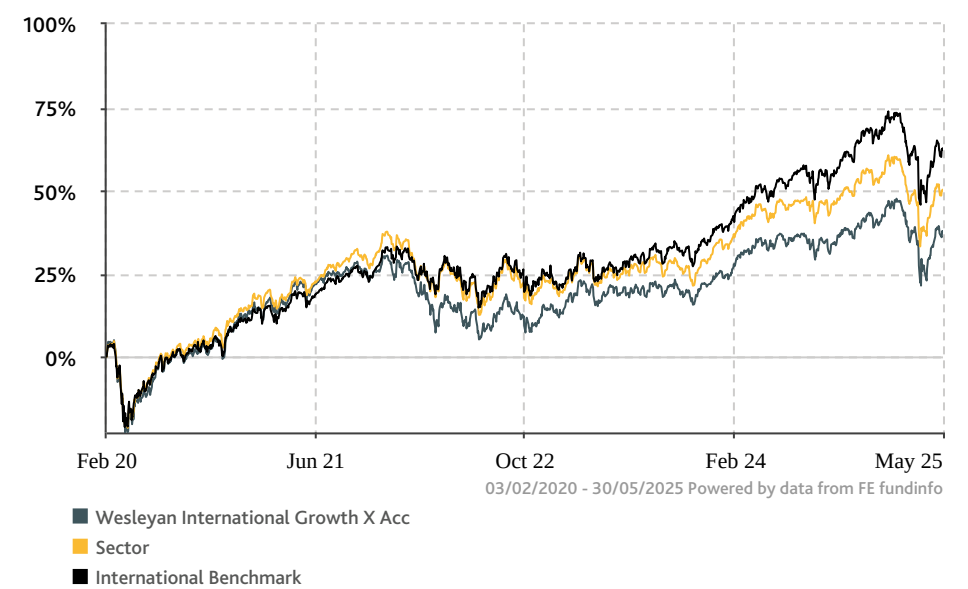
WESLEYAN INTERNATIONAL GROWTH FUND (CLASS X) ACC

FUND OBJECTIVE

The fund aims to provide capital growth over a period of at least five years. We measure the success of the fund as outperforming a benchmark over a rolling 5-year period. We do this by comparing the investment performance, after fees and charges, to a composite benchmark which reflects the current risk rating of the fund. This benchmark is a target for the fund. SECTOR BREAKDOWN (as at 31/05/2025)

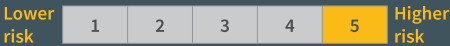


REGIONAL BREAKDOWN (as at 31/05/2025)
