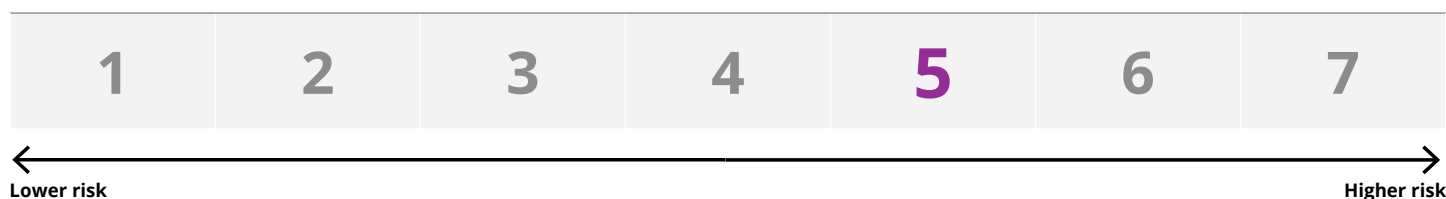
What is this Product?

Ordinary Shares in CEIBA Investments Limited, an actively managed investment company, registered in Guernsey and listed on the Specialist Fund Segment of the London Stock Exchange. The Specialist Fund Segment is intended for institutional, professional, professionally advised and knowledgeable investors who understand, or who have been advised of, the potential risk from investing in companies admitted to the Specialist Fund Segment. The Company's articles of association prohibit United States persons from having an interest in the Company.

The Company's investment objective is to provide a regular level of income and substantial capital growth from investing in Cuban real estate and other assets directly related to Cuba, with a focus on the tourism-related and commercial property sectors. The majority of the Company's investments are held through joint venture shareholdings or subsidiary companies. The Company may borrow to acquire assets. The Company does not have a fixed life but the Company may be wound up following a proposal from the directors and its approval by the shareholders. Aberdeen Standard Fund Managers Limited may not unilaterally terminate the Company. Shares in the Company are bought and sold on a stock market. Investment in the Company is only suitable for investors who are comfortable with the risks and investment time horizon set out in this document and may not be appropriate if you plan to sell some or all of your shares within 5 years. What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Company is not able to pay you.



The risk indicator assumes you keep the product for at least 5 years. The actual risk can vary significantly. The value of investments and the income from them can go down as well as up, and you may get back less than you invested.

We have classified this product as 5, which is a medium high risk class. This rates the potential losses from future performance at a medium high level, and poor market conditions could impact the amount you could get back.

If the product is not held for the recommended holding period, the potential risk may be significantly higher than the one shown above. This product does not include any protection from future market performance so you could lose some or all of your investment.

What happens if the Company is unable to pay out?

What are the costs?

How long should I hold it and can I take money out early?

This product has no required minimum holding period but is designed for medium to long-term investment.
