What is this Product?

Product Type

This is a regular savings plan with payments invested in the Wesleyan Low Risk/Reward Fund (s1).

Objective

The Wesleyan Low Risk/Reward Fund aims to provide capital growth over a medium to long term period by investing in UK and International shares, fixed interest stocks, property, cash and other related investments.

Intended For

This product is suitable for retail investors who are looking for better returns than cash based investments that aim to beat inflation and accept investing a portion of their money in higher risk assets to achieve this. This means when investments are cashed in they may be worth less than the amount invested. It is designed to form part of a portfolio of investments.

There is an additional 1% life cover in the event of your death.

What are the risks and what could I get in return?

The Summary Risk Indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

What are the costs?

How long should I hold it and can I take money out early?

Recommended Holding Period: 5 years plus
