What is this product?

It is an insurance-based investment contract. You can choose to invest in one or more funds we offer. Each fund is divided into units (like shares). Your bond's value is determined by the number of units it holds in each fund, and the price of those units.

This Fund invests entirely into a fund designed and operated by BNY Mellon. A summary of the manager's description is as follows: The Fund aims to achieve capital growth over the long term (5 years or more).

The Sub-Fund is actively managed and will invest at least 70% in equity (company shares) and equity-related securities (such as common and preferred stock, American depositary receipts and global depository receipts), listed real estate investment trusts ("REIT"s) and master limited partnerships ("MLP's"), issued by large capitalisation companies located in the US. This includes securities of companies which at the time of purchase have a market capitalisation of US\$2 billion or above.

The Sub-Fund may invest up to 30% of the portfolio in equity or equity-related securities of companies (which will be listed or traded on Eligible Markets) located in the US which are smaller in capitalisation or in equity or equity-related securities or companies which neither have their registered office in the US nor carry out a predominant part of their economic activities in the US.

The Sub-Fund may also invest up to 10% of the portfolio in collective investment schemes (including but not limited to another Sub-Fund or Sub-Funds of the Company or other BNY Mellon funds) and derivatives (including but not limited to currency-related derivatives).

Derivatives may be used for investment purposes as well as for efficient portfolio management and hedging. It is not expected that the use of derivatives will materially affect the overall risk profile of the Sub-Fund.

The bond is designed for investors who:

- want potential capital growth or an income over the medium to long-term (at least 5 to 10 years).
- want to initially invest at least £10,000 or make additional payments of at least £1,000.
- accept their bond's value will fluctuate and they might not get back the full amount invested.

On death, we'll pay either 100% or 101% of the bond's value, depending on your age at the start of the bond (or 110% if death is caused by an accident). There is no additional cost for this cover. The bond has no fixed term and will continue until you ask us to cash it in, or you die.

What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of the Investment Bond investing in the CM BNY Mellon US Equity Income Life compared to other products and funds. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.





The risk indicator assumes you keep the product for 10 years and that you remain invested in this Fund. If you change funds, the risk indicator may change.

We have classified this Fund as 5 out of 7, which is a medium high risk class. This rates the potential losses from future performance at a medium high

The value of your investment, and any income from it, is not guaranteed and can go up and down depending on the performance of each of the assets in the Fund. This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme - see the section 'What happens if Scottish Widows Limited is unable to pay out'. The indicator shown above does not consider this protection.



Investment performance information

The value of the Fund's equity securities is significantly influenced by a range of economic and equity market performance factors such as economic growth, political, economic and international developments and market trends. The decisions taken by the Fund manager to select individual company securities and the resulting aggregate investments characteristics such as the Fund's style, sector and country exposures can also materially impact performance.

The Fund will measure its performance against the S&P 500 NR Index as a comparator benchmark (the "Benchmark"). The Fund will use the Benchmark as an appropriate comparator because it includes a broad representation of the asset classes, sectors and geographical area in which the Fund predominantly invests.

What could affect my return positively?

The Fund is likely to achieve higher returns if conditions in overall equity markets are favourable. The Fund will achieve higher returns if the allocation to countries, sectors and securities selected by the Fund manager provides positive returns over time and if these securities provide superior returns than the market average. The Fund's asset values are influenced positively if the sterling currency falls in relation to other major currencies, in particular the US Dollar.

What could affect my return negatively?

The Fund is likely to achieve lower or negative returns if conditions in overall equity markets are unfavourable. The Fund will achieve lower returns if the allocation to countries, sectors and securities selected by the Fund manager provides negative returns over time or if these securities provide an inferior return compared to the market average. The Fund's asset values are influenced negatively if the sterling currency rises in relation to other major currencies, in particular the US Dollar.

If you cash in your investment at a time of adverse market conditions, when values of equity investments are down, you could achieve lower than expected returns, including the possibility that you will make a loss on your investment.

How long should I hold it and can I take money out early?

As the bond is a medium to long-term investment, it's designed to be held for at least five to ten years, but can be held for as long as you want. When you cash in, or if you switch between funds, there may be a delay of up to one month for this Fund. The value of your bond can go down as well as up and you could get back less than you invested, particularly if you cash in your bond in the short term.

You can make regular and one-off withdrawals. Withdrawals could be greater than any growth achieved and could reduce your bond's value below the amount invested. You should refer to the Additional Information Document for the conditions that apply and information on tax.

For new investments, you can change your mind within 30 days of when you receive your cancellation notice. You'll need to tell us in writing and we'll return your money less any fall in its value.
