# What is this product?

It is an insurance-based investment contract. You can choose to invest in one or more funds we offer. Each fund is divided into units (like shares). Your bond's value is determined by the number of units it holds in each fund, and the price of those units.

This Fund invests entirely into a fund designed and operated by Fidelity. The manager describes their Fund as follows: The Fund aims to increase the value of your investment over a period of 5 years or more.

The Fund will invest at least 70% in equities (and their related securities) of US companies (those domiciled, incorporated or having significant business in the US and those which are listed in the US) and aims to hold a concentrated portfolio of 30-40 securities. The Fund is actively managed and will invest in a concentrated portfolio of companies the Investment Manager considers will outperform over the period. The Investment Manager identifies suitable opportunities for the Fund utilising in-house research and investment capabilities. The Investment Manager will, when selecting investments for the Fund and for the purposes of monitoring risk, consider the S&P 500 Index. However, the Investment Manager has a wide degree of freedom relative to the index and may take larger, or smaller, positions in companies, and/or may invest outside the index, to take advantage of investment opportunities. This means the Fund's investments and therefore performance may vary significantly from the index. The Fund may also invest into other transferable securities, collective investment schemes, money market instruments, cash and deposits and is also able to use derivatives for efficient portfolio management.

The bond is designed for investors who:

- · want potential capital growth or an income over the medium to long-term (at least 5 to 10 years).
- want to initially invest at least £10,000 or make additional payments of at least £1,000.
- accept their bond's value will fluctuate and they might not get back the full amount invested.

On death, we'll pay either 100% or 101% of the bond's value, depending on your age at the start of the bond (or 110% if death is caused by an accident). There is no additional cost for this cover. The bond has no fixed term and will continue until you ask us to cash it in, or you die.

## What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of the Investment Bond investing in the CM Fidelity American Fund compared to other products and funds. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.





The risk indicator assumes you keep the product for 10 years and that you remain invested in this Fund. If you change funds, the risk indicator may change.

We have classified this Fund as 5 out of 7, which is a medium high risk class. This rates the potential losses from future performance at a medium high

#### **Investment performance information**

The value of the Fund's equity securities is significantly influenced by a range of economic and equity market performance factors such as economic growth, political, economic and international developments and market trends. The decisions taken by the Fund manager to select individual company securities and the resulting aggregate investments characteristics such as the Fund's style, sector and country exposures can also materially impact performance.

The Fund is actively managed and references S&P 500 Index (Net) for comparative purposes only.

#### What could affect my return positively?

### What could affect my return negatively?

The Fund will achieve lower returns if the allocation to countries, sectors and securities selected by the Fund manager provides negative returns over time or if these securities provide an inferior return compared to the market average. The Fund's asset values are influenced negatively if the sterling currency rises in relation to other major currencies, in particular the US Dollar.

If you cash in your investment at a time of adverse market conditions, when values of equity investments are down, you could achieve lower than expected returns, including the possibility that you will make a loss on your investment.

## How long should I hold it and can I take money out early?

As the bond is a medium to long-term investment, it's designed to be held for at least five to ten years, but can be held for as long as you want. When you cash in, or if you switch between funds, there may be a delay of up to one month for this Fund. The value of your bond can go down as well as up and you could get back less than you invested, particularly if you cash in your bond in the short term.

You can make regular and one-off withdrawals. Withdrawals could be greater than any growth achieved and could reduce your bond's value below the amount invested. You should refer to the Additional Information Document for the conditions that apply and information on tax.

For new investments, you can change your mind within 30 days of when you receive your cancellation notice. You'll need to tell us in writing and we'll return your money less any fall in its value.
